Self Direction Act of 2022 Implementation

Continued opportunity for DDA to address our concerns and for stakeholder input

October, 1 2022 the law is effective

January 1, 2023 deadline for Waiver changes

Key Elements of the Law

- Allows support broker hours up to 30 hrs/mo* and increases the scope of work
 - Requires a Support Broker if family is hired as staff
- Removes cap of \$5,000 for IFDGS*
- Requires the training of CCSes on Self-Directed Services
- Requires people be informed about all Waiver options
- Allows for transportation reimbursement for specialized vehicles (just began as of 7/21/22)
- Requires Parity in funding and Transparency in process
- Ensures overnight supports and family as staff remain available
- * Comes out of unallocated funds

SDAN...

Has had two meetings with DDA to go over Act's intent

 Remains committed to continuing to work with you, our members and with DDA on the implementing the new law

FMCS (FMS) UPDATE

EVERYONE will have to formally choose an FMS using a special form submitted by your CCS - NOV 15th

DDA's Information Fairs begin August 1st (virtual) – others in person

DDA informed us all on July 21st that FMS fees will now come out of your budget.

IMPORTANT Deadlines

- Choose an FMCS between August 1 and November 15 Even if you choose to stay with The ARCCCR
- MUST make a choice or one will be made FOR you
- Attend at least one DDA Information fair in August
- Choose a start date either October 1 or January 1
- If you change FMCSes, you must submit "new hire packets" for all employees and vendor information 30 days in advance of start dates
- DDA states MedSource will no longer provide services after December 31, 2022

The DDA is holding event fairs including a virtual kickoff along with in-person regional events around the State. 
