

Reminders...

 October 6th: Waiver renewal comments due, email to wfb.dda@maryland.gov. SDAN comments shared to members October 4th and posted to www.marylandsds.org.

- November 15th: Participants MUST proactively choose a Fiscal Management and Counseling Service (FMCS) or one will be chosen FOR you. DDA FMCS info fairs in October—<u>register here</u>.
- July 2022 Rate Change: Need additional funds? Speak with your support broker or CCS to confirm you got the increase.
- January 31st, 2023: Portions of Appendix K extended BUT overtime for Family as Staff (FAS) ends September 30th—<u>read DDA's email here</u>.
- December 1^{st:} Finger printing—mandatory for ALL staff and Support Brokers, both existing and new.

January 1, 2023 Waiver changes submitted by DDA with Effective date of July 1, 2023

New Services and Key Changes to Celebrate

- Day to Day Administrator position (sustainability)*
- Supervised Overnight supports are added to Awake Overnight
- Personal Supports 82/hour restriction lifted
- Individual and Family Directed Goods and Services (IFDGS) \$5,000 cap lifted (but still needs DDA approval)
- Independence Plus designation was requested by DDA which shows that the waiver shows a strong commitment to Self Direction (SD).
- * Comes out of unallocated funds

New Services and Key Changes to Celebrate

- Allows Support Broker (SB) hours up to 30 hrs/month* and expands what they can do (up to 4 hours still fully funded by waiver service authorization)
- New waiver requires a Support Broker, if family is paid staff
- Transparency in review process, including access to MD-LTSS Case Management System (coming)
- Budget authority for Shared Living

* Comes out of unallocated funds

"Day to Day" Administrative Support position (optional)

Support to help people sustain their SD services (not direct support)

Customizable and flexible to suit the person and their TEAM

Day to day admin supports to include assistance with all aspects of household and personal management

Source of funds is unallocated – Concern about placement under IFDGS but otherwise positive

Supervision Overnight Added

In addition to Awake Overnights is the new service of Supervision Overnight

With an assessed need

From Personal Support hours

Support Broker Changes

Expanded duties

DDA funds up to 4 hours but up to 30 hours is available using unallocated funds

Mandatory for participants with legal guardian, rep payee, or family as staff – Protects state from perception of conflict of interest and protects participants who may not chose to have their family as staff or as their only staff.

(Support Broker advocates for the person!)

Individual and Family Directed Goods and Services (IFDGS)

Ability to spend over \$5,000 with DDA approval – source of funds is unallocated

Definition of allowable items expanded to align with Centers for Medicare and Medicaid Services (CMS) guidelines SDAN Waiver Concerns and Comments Waiver does not include details – Policy becomes crucial

Lack of explicit acknowledgment that Self Direction is a 1:1 service/rate

Concern that some individuals need skilled nursing services and DDA doesn't offer the service

Remove the words "representative payee as staff" from the need to have a mandatory support broker SDAN Waiver Concerns and Comments Smart Phones should be INCLUDED if needed for assistive technology and not available/appropriate from other sources

Internet Access should be INCLUDED

Awake overnights should drop Health Risk Screening Tool (HRST) of 4 and rely on Behavior Plan or Nursing Plan as documentation of support need

Remove "extraordinary circumstances" from support broker expanded hours

SDAN Waiver Concerns Community includes a person's home, so Community Development Services (CDS) should be allowable in the home

Budget modification should allow for funds to move across approved employer authority services and to 'reallocate' funds which came out of unallocated funds

IFDGS what criteria will be used to approve or disapprove participant choice (contrary to SD Act of 2022)

Electronic Visit Verification (EVV) is coming... Please give us your concerns in the CHAT!!!

- We don't know when... but we do know soon
- Each FFMCS will have its own system
- DDA/MDH (Maryland Dept. of Health) said EVV will be required for Personal Supports and Respite

 Appears as though MDH is doing more than is required by federal law and Centers for Medicare and Medicaid Services (CMS) guidelines

• Protect your employees pay—learn the systems!
