1 AN ACT concerning

2 **Developmental Disabilities Administration – Self-Directed Services**  
3 **(Self-Direction Act of 2022)**

4 FOR the purpose of requiring the Developmental Disabilities Administration to establish  
5 and provide training materials to coordinators of community services on  
6 self-directed services; requiring coordinators of community services to educate a  
7 certain recipient on ~~self-directed services~~ all models of services available to the  
8 recipient at certain times; providing for the services and manner of delivering  
9 services that the Administration provides to a recipient who receives self-directed  
10 services; requiring that home- and community-based services waiver recipients  
11 receive support broker services; requiring the Administration to submit a certain  
12 waiver application for a certain purpose by a certain date; requiring the  
13 Administration to leverage certain federal funding for a certain purpose; and  
14 generally relating to Developmental Disabilities Administration services.

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
6 That the Laws of Maryland read as follows:

7 **Article – Health – General**

8 7–101.

9 (a) In this title the following words have the meanings indicated.

10 (b) “Administration” means the Developmental Disabilities Administration.

11 (c) (1) “Admission” means the process by which an individual with an  
12 intellectual disability is accepted as a resident in a State residential center.

13 (2) “Admission” includes the physical act of the individual entering the  
14 facility.

15 (d) (1) “Alternative living unit” means a residence that:

16 (i) Provides residential services for individuals who, because of  
17 developmental disability, require specialized living arrangements;

18 (ii) Admits not more than 3 individuals; and

19 (iii) Provides 10 or more hours of supervision per unit, per week.

20 (2) “Alternative living unit” does not include a residence that is owned or  
21 rented by:

22 (i) 1 or more of its residents; or

23 (ii) A person who:

24 1. Is an agent for any of the residents; but

25 2. Is not a provider of residential supervision.

26 (e) “Claim” has the meaning stated in § 2–601 of this article.

27 (f) “Deputy Secretary” means the Deputy Secretary for Developmental  
28 Disabilities.

1 (g) “Developmental disability” means a severe chronic disability of an individual  
2 that:

3 (1) Is attributable to a physical or mental impairment, other than the sole  
4 diagnosis of mental illness, or to a combination of mental and physical impairments;

5 (2) Is manifested before the individual attains the age of 22;

6 (3) Is likely to continue indefinitely;

7 (4) Results in an inability to live independently without external support  
8 or continuing and regular assistance; and

9 (5) Reflects the need for a combination and sequence of special,  
10 interdisciplinary, or generic care, treatment, or other services that are individually planned  
11 and coordinated for the individual.

12 (h) “External support” means:

13 (1) Periodic monitoring of the circumstances of an individual with respect  
14 to:

15 (i) Personal management;

16 (ii) Household management; and

17 (iii) The use of community resources; and

18 (2) Rendering appropriate advice or assistance that may be needed.

19 (i) “Fee-for-service” means a method for payment that requires a person to  
20 submit a claim for payment to the Department for each service performed.

21 (j) “Group home” means a residence that:

22 (1) Provides residential services for individuals who, because of  
23 developmental disability, require specialized living arrangements;

24 (2) Admits at least 4 but not more than 8 individuals; and

25 (3) Provides 10 or more hours of supervision per home, per week.

26 (k) “Habilitation” means a process by which a provider of services enables an  
27 individual to acquire and maintain life skills to cope more effectively with the demands of  
28 the individual’s own person and environment and to raise the level of the individual’s  
29 mental, physical, social, and vocational functioning.

1 (L) (1) “INDIVIDUAL-DIRECTED ~~FAMILY~~ AND FAMILY-DIRECTED GOODS  
 2 AND SERVICES” MEANS SERVICES, EQUIPMENT, ~~THERAPIES, TRANSPORTATION~~  
 3 ACTIVITIES, OR SUPPLIES FOR INDIVIDUALS WHO SELF-DIRECT SERVICES THAT:

4 (I) RELATE TO A NEED OR GOAL IDENTIFIED IN THE  
 5 PERSON-CENTERED PLAN OF SERVICE;

6 (II) MAINTAIN OR INCREASE INDEPENDENCE;

7 (III) PROMOTE OPPORTUNITIES FOR COMMUNITY LIVING AND  
 8 INCLUSION; AND

9 (IV) ARE NOT AVAILABLE UNDER ~~A~~ ANOTHER WAIVER SERVICE  
 10 OR SERVICES PROVIDED UNDER THE STATE PLAN ESTABLISHED IN SUBTITLE 3 OF  
 11 THIS TITLE.

12 (2) “INDIVIDUAL-DIRECTED ~~FAMILY~~ AND FAMILY-DIRECTED GOODS  
 13 AND SERVICES” INCLUDES ~~ANY OTHER~~ ALL GOODS OR SERVICES AUTHORIZED  
 14 UNDER BY REGULATIONS ADOPTED OR GUIDANCE ISSUED BY THE FEDERAL  
 15 CENTERS FOR MEDICARE AND MEDICAID SERVICES UNDER § 1915(C) OF THE  
 16 SOCIAL SECURITY ACT.

17 [(l)] (M) (1) “Individual support services” means an array of services that are  
 18 designed to increase or maintain an individual’s ability to live alone or in a family setting.

19 (2) “Individual support services” include:

20 (i) In-home assistance with meals and personal care;

21 (ii) Counseling;

22 (iii) Physical, occupational, or other therapies;

23 (iv) Architectural modification; and

24 (v) Any other services that the Administration considers  
 25 appropriate to meet the individual’s needs.

26 (3) “Individual support services” does not include full day or residential  
 27 services.

28 [(m)] (N) “Intellectual disability” means a developmental disability that is  
 29 evidenced by significantly subaverage intellectual functioning and impairment in the  
 30 adaptive behavior of an individual.

1           [(n)] (O)       “Knowingly” has the meaning stated in § 2–601 of this article.

2           [(o)] (P)       “Live independently” means:

3                   (1)    For adults:

4                           (i)    Managing personal care, such as clothing and medication;

5                           (ii)   Managing a household, such as menu planning, food preparation  
6 and shopping, essential care of the premises, and budgeting; and

7                           (iii)   Using community resources, such as commercial establishments,  
8 transportation, and services of public agencies; or

9                   (2)    For minors, functioning in normal settings without the need for  
10 supervision or assistance other than supervision or assistance that is age appropriate.

11           [(p)] (Q)       “Meaningful day services” means employment supports or home– and  
12 community–based supports, other than residential services, that assist an individual in  
13 developing and maintaining skills, interests, and personalized connections that may create  
14 opportunities for paid employment, increased independence, or meaningful relationships  
15 with other individuals in the community.

16           (R)    “**PERSON-CENTERED PLAN OF SERVICE**” MEANS THAT A PLAN FOR  
17 **SERVICES AND SUPPORTS:**

18                   ~~(1)    REFLECTS WHAT IS IMPORTANT TO THE INDIVIDUAL AND FOR THE~~

28                           (1)    **THE INDIVIDUAL’S PREFERENCES AND INTERESTS**  
29 **RELATED TO ACHIEVING THE INDIVIDUAL’S DESIRED LIFESTYLE; AND**

1                   **(II) THE SUPPORTS REQUIRED TO ACHIEVE THE INDIVIDUAL'S**  
 2 **DESIRED LIFESTYLE AND PROVIDED IN A MANNER THAT ENABLES THE INDIVIDUAL**  
 3 **TO HAVE CONTROL OVER THE INDIVIDUAL'S DAILY LIFE AND MAINTAINS THE**  
 4 **INDIVIDUAL'S HEALTH AND WELFARE; AND**

5                   **(4) ALIGNS SERVICES AND SUPPORTS TO ENSURE THAT THE**  
 6 **INDIVIDUAL HAS ACCESS TO THE FULL BENEFITS OF COMMUNITY LIVING IN A**  
 7 **MANNER THAT EMPHASIZES THE INDIVIDUAL'S QUALITY OF LIFE, WELL-BEING, AND**  
 8 **INFORMED CHOICE.**

9           **[(q)] (S)**       “Provider” means an individual who is licensed or certified under  
 10 Subtitle 9 of this title and provides services to:

11                   (1)     A recipient; or

12                   (2)     An individual with a developmental disability who receives funding for  
 13 services from a source other than the Administration.

14           **[(r)] (T)**       “Recipient” means an individual who receives services funded by the  
 15 Administration under this title.

16           **[(s)] (U)**       “Release” means a permanent, temporary, absolute, or conditional  
 17 release of an individual from a State residential center.

18           **[(t)] (V)**       “Residential services” means individualized support and services that  
 19 assist an individual in developing and maintaining skills in living in the community.

20           **(w) (1) “SELF-DIRECTED SERVICES” MEANS WAIVER PROGRAM**  
 21 **SERVICES:**

22                   **(I) FOR WHICH PARTICIPANTS OR THEIR REPRESENTATIVES**  
 23 **HAVE DECISION-MAKING AUTHORITY OVER AND TAKE DIRECT RESPONSIBILITY FOR**  
 24 **MANAGEMENT OF THE SERVICES WITH THE ASSISTANCE OF AVAILABLE SUPPORTS**  
 25 **CHOSEN BY THE PARTICIPANT OR THE PARTICIPANT'S REPRESENTATIVE; AND**

26                   **(II) THAT ARE PROVIDED IN A MANNER THAT ~~FURTHERS:~~**

27                   **1. FURTHERS THE RIGHT OF INDIVIDUALS WITH**  
 28 **DISABILITIES, REGARDLESS OF THE PHYSICAL OR INTELLECTUAL CAPACITY OF THE**  
 29 **INDIVIDUALS, AND THEIR REPRESENTATIVES, AS APPLICABLE, TO MAKE CHOICES**  
 30 **ABOUT AND DIRECT ALL ASPECTS OF THEIR LIVES, INCLUDING ~~THROUGH CONTROL~~**  
 31 **OVER RECEIPT OF, AND FUNDING FOR, SUPPORT SERVICES BY CHOOSING AND**  
 32 **CONTROLLING THE DELIVERY OF WAIVER SERVICES, WHO PROVIDES THE SERVICES,**  
 33 **AND HOW SERVICES ARE PROVIDED; AND**

7 **EMPLOYEES AND VENDORS WHO FURNISH THE INDIVIDUAL’S SERVICES; AND**

17                   **[(u)] (X)**       “Services” means residential, day, or other services that provide for  
18 evaluation, diagnosis, treatment, care, supervision, assistance, or attention to individuals  
19 with developmental disability and that promote habilitation of these individuals.

20                   **[(v)] (Y)**       “Services coordination” means a service that consists of the following 3  
21 major functions that are designed to assist an individual in obtaining the needed services  
22 and programs that the individual desires in order to gain as much control over the  
23 individual’s own life as possible:

24                           (1) Planning services;

25                           (2) Coordinating services; and

26                           (3) Monitoring service delivery to the individual.

27                   **[(w)] (Z)**       “State residential center” means a licensed facility operated by the  
28 State that provides residential and habilitation services to individuals with an intellectual  
29 disability who are at least 18 years old and meet the criteria set forth in § 7-502 of this  
30 title.

1           (AA) ~~“SUPPORT BROKER” MEANS A PERSON WHO ADVOCATES ON BEHALF OF~~  
 2 ~~AND AS DIRECTED BY~~ WORKS AT THE DIRECTION OF AND FOR THE BENEFIT OF AN  
 3 INDIVIDUAL WHO USES SELF-DIRECTED SERVICES, INCLUDING BY ASSISTING THE  
 4 INDIVIDUAL OR ~~THE INDIVIDUAL’S FAMILY OR OTHER REPRESENTATIVE~~ ANOTHER  
 5 INDIVIDUAL CHOSEN BY THE INDIVIDUAL WITH:

6           (1) MAKING INFORMED DECISIONS IN ARRANGING FOR, DIRECTING,  
 7 AND MANAGING SERVICES THE INDIVIDUAL RECEIVES, INCLUDING DECISIONS  
 8 RELATED TO PERSONNEL REQUIREMENTS AND RESOURCES NEEDED TO MEET THE  
 9 REQUIREMENTS;

10           (2) ACCESSING AND MANAGING IDENTIFIED SUPPORTS AND  
 11 SERVICES ~~BEST SUITED~~ FOR THE INDIVIDUAL; AND

12           (3) PERFORMING OTHER TASKS AS ASSIGNED BY THE INDIVIDUAL  
 13 AND AS AUTHORIZED BY REGULATIONS ADOPTED OR GUIDANCE ISSUED BY THE  
 14 FEDERAL CENTERS FOR MEDICARE AND MEDICAID SERVICES UNDER § 1915(C) OF  
 15 THE SOCIAL SECURITY ACT.

16           [(x)] (BB) “Support services” means supports that assist an individual to maintain  
 17 or improve the individual’s functional abilities, enhance interactions, or engage in  
 18 meaningful relationships in the home or community.

19           [(y)] (CC) “Treatment” means any education, training, professional care or  
 20 attention, or other program that is given to an individual with developmental disability.

21           [(z)] (DD) “Vocational services” means a service that provides job training and  
 22 placement, supported employment and training in acceptable work behaviors, and  
 23 vocationally-related social and other skills.

24           [(aa)] (EE) “Waiver program” means each Medicaid Home- and  
 25 Community-Based Services Waiver funding program submitted by the Department and  
 26 approved by the federal Centers for Medicare and Medicaid Services in accordance with §  
 27 1915(c) of the Social Security Act that is overseen and administered by the Administration.

28           [(bb)] (FF) “Waiver program services” means services funded by the  
 29 Administration in accordance with a waiver program, including:

30           (1) Meaningful day services;

31           (2) Residential services; and

32           (3) Support services.



1 (A) THE ADMINISTRATION, IN CONSULTATION WITH STAKEHOLDERS,
